## **Biographical Sketch**

Hatton W. Sumners was born May 30, 1875, in Tennessee. In 1893 his family migrated to Texas to live with relatives in Garland. He was admitted to the bar in 1897 after "reading law" with Dallas Attorney, Alfred P. Wozencraft. Sumner practiced law in Texas, was elected prosecuting attorney of Dallas County in 1900, where he served two terms, until his election as a Democrat to the House of Representatives in 1912. In 1919 Sumner joined the House Committee on the Judiciary and in 1931 rose to became head of the Committee and remained chairman until he retired from Congress in 1946. After retirement Sumner became Director of Law and Research at the Southwestern Legal Foundation and lived at the Lawyers' Inn on the campus of Southern Methodist University in Dallas until his death on April 19, 1962. Hatton Sumners is interred in the Knights of Pythias Cemetery, Garland, Texas.
