# Dallas Historical Society

## Policy Statement 2021

The Dallas Historical Society wants all (Guests, Visitors and Patrons) who visit and attend events, exhibits and displays to have a pleasant and rewarding experience. We need volunteers to help make this possible. Thank you for your interest in volunteering with the Dallas Historical Society. For that reason, please read carefully the following statement.

The Dallas Historical Society will maintain a drug and alcohol-free workplace. This policy applies to all who represent the Dallas Historical Society. The manufacture, distribution, dispensation, possession, or use of controlled substances and inhalants while representing the Dallas Historical Society is prohibited.

The Dallas Historical Society is committed to providing an environment free of unlawful harassment. Examples of such behavior include, but are not limited to:

- a) Verbal conduct not conducive to a safe and worry-free environment
- b) Visual conduct such that is derogatory and/or sexually oriented
- c) Physical conduct that is threatening or demanding,
- d) Retaliation for having reported such offense

If you believe you have been subjected to any form of discrimination or harassment, then report it immediately to your supervisor and the Dallas Historical Society will investigate immediately and take corrective action. All complaints will be taken seriously by the Dallas Historical Society. Violators of this policy will be subject to immediate dismissal.

Any volunteer with the Dallas Historical Society gives permission to the Dallas Historical Society to obtain information regarding a criminal background check. It is understood that any obtained information will be used to determine eligibility to volunteer for the Dallas Historical Society. It is also understood that such a background check may be performed at any time a volunteer is representing the Dallas Historical Society.

It is understood that at any time any volunteer may be asked not to return as a volunteer. The volunteer agrees to remise, release, and forever discharge and agree to indemnify and hold the Dallas Historical Society, officers, employees and agents harmless from and against any and all causes of actions, suits, liabilities, costs, debts, and sums of money, claims and demands whatsoever, and any and all related attorneys' fees, court costs, and other expenses resulting from a disagreement about volunteer status or eligibility at the Dallas Historical Society. It is also understood that this agreement does not constitute an employment agreement with obligations by either party. It is understood that completion of this form does not guarantee status as a Dallas Historical Society Volunteer.
