Abstract The Caruth family was one of the pioneer families of Dallas, most

notable for amassing large tracts of land and shaping the landscape of the city over several generations. The Caruth Family Collection contains correspondence, legal documents such as deeds and title abstracts, financial documents such as bills and receipts, and other materials that relate to the personal lives and business dealings (mainly in real estate) of members of the Caruth family, primarily William Barr Caruth, Mattie Caruth, Walter Caruth, Sr., and W. W.

Historical Note

Biographical William Barr Caruth (1827-1885) moved to Dallas in 1848, and his

brother Walter Caruth, Sr. (1826-1897) joined him in 1849. They established the W. Caruth & Brother General Store, which was successful enough that they were able to use the funds generated from it to acquire land that eventually amounted to over 30,000 acres and that stretched north from downtown Dallas to Forest, and east from Preston to Abrams. The land was used initially for cotton, and later, dairy and cattle operations. The brothers also served in the Confederate army during the Civil War, and they continued to work together until 1881. William Barr Caruth's wife, Mattie Caruth (1836-1907) managed the Caruth Homestead and the family's real estate property after her husband died of skin cancer. ¹

Their son, W. W. Caruth, Sr. (1876-1949), continued to oversee the land and real estate holdings of the Caruth family. Notably, in 1911, he donated and sold almost 800 acres of land to Southern Methodist University in order to help secure its place in Dallas. W. W. Caruth Sr.'s son, W. W. Caruth, Jr. (1912-1990), developed and leased large amounts of land from the family's estate throughout his lifetime, essentially shaping the landscape of north Dallas.²

Scope and Contents

The Caruth Family Collection contains the papers of members of the Caruth family, including Mattie Caruth, William Barr Caruth, W. W. Caruth, Sr., W. W. Caruth, Jr., Walter Caruth, Sr., and Walter Caruth, Jr. The types of materials found within the collection include correspondence, legal documents (such as title abstracts, affidavits, statements, certificates of title, chains of title, contracts, deeds, leases, petitions, power of attorney forms, releases, wills, and oaths), court papers (such as reports, lists of evidence, judgments, deeds, orders, reports of sale, answers, notices, affidavits, bills of cost, citations, and releases), and financial documents (such as account books, bank books, deposit slips, bills, receipts, cancelled checks, certificates, Confederate bonds, ledgers, financial lists, notes, and statements).

There are four series in the collection: Correspondence, Legal Documents, Court Papers, and Financial Documents.

The first series, Correspondence (1861-1958, Undated), contains correspondence between members of the Caruth family and others. One of the main topics is the Rock Creek Mining Company, of which Mattie Caruth and her nephew, Walter Caruth, Jr., were involved in. There is also correspondence related to other business matters involving Mattie Caruth, William Barr Caruth, W. W. Caruth, Sr., and Walter Caruth, Sr., and personal correspondence between members of the Caruth family and others.

The second series, Legal Documents (1847-1927, Undated), contains title abstracts, affidavits, certificates of title, chains of title, contracts, deeds, leases, petitions, power of attorney forms, releases, statements, wills, and an amnesty oath pledged to the U.S. government and signed by William Barr Caruth. These documents illustrate the business activity of members of the Caruth family in the area of real estate, including their involvement with the

development of Southern Methodist University.

The third series, Court Papers (1849-1926, Undated), contains answers, affidavits, bills of cost, citations, deeds, judgments, lists of evidence, notices, orders, releases, reports, reports of sale, and other court documents. These papers relate to *Annie Caruth, et al vs. W. W. Caruth, Caruth vs. McCommas, Grigsby vs. Bowles, Irvin vs. Hoffmeyer, Stone vs. Herndon*, and the estates of Emily G. Caruth and others.

The fourth series, Financial Documents (1856-1949, Undated), contains account books, bank books, deposit slips, bills, receipts, cancelled checks, certificates, Confederate bonds, ledgers, financial lists, notes, and statements related to members of the Caruth family, and in particular, Mattie Caruth and W. W. Caruth, Sr.

This collection offers insight into the areas of real estate, mining, the Caruth family, and the history and development of Dallas.
