Abstract: This collection contains the personal, political, legislative, general papers and speeches of Hatton W. Sumners, Congressman from Texas from 1912-1946, head of the judiciary committee 1931-1946. Includes newspaper clippings, postcards, letters, etc. received by him over the course of his life. Bills, laws, and supreme court cases Sumners advocated for and against are also included in the collection, and correspondence sent and received by Sumners relating to World War I and World War II. Post-congressional papers, 1947-1962, are also included in the collection. Scrapbooks of newspapers, in addition to photographs, and rough drafts of books Sumners wrote are also present in the collection.

Biographical Sketch

Hatton W. Sumners (May 30, 1875 - April 19, 1962) was the second child of William A. and Anna Elizabeth (Walker) Sumners. The family moved to the Dallas area in 1849, and as an adult was elected Dallas County attorney. Sumners would later serve as a Democratic Congressman from 1913–1947. During this time, he was the Chairman of the Judiciary Committee as well as being involved in several high-profile legislative measures.

Scope and Contents:

The collection contains sixty-seven boxes of general correspondence from 1902-1963 including his personal correspondence with his parents and sister. Personal business and land papers are also included. Sumner's legislative correspondence consists of thirty-three boxes dealing with sundry laws, committees, and issues before congress, 1912-1947 including Sumner's role in the FDR Court Packing Scheme of 1937. Thirteen boxes of newspaper clippings from 1898-1947 are included in the collection dealing with a host of political issues and controversies both local and national. Seven boxes contain Sumner's speeches delivered to numerous organizations around the country and before congress over the course of his life.
