Abstract	The personal papers of Mrs. E. B. Crawford and Mr. A. A. Braswell, along with the records of the E. J. Crawford Burial Association, Crawford Undertaking Company, First Grande Life Insurance Company, Sun Mutual Burial Association, the Knights of Pythias, and the Knights of Pythias Federal Credit Union, contribute to Dallas's past, particularly within the timeframe of the 1930s-1970s, through their representation of important figures and organizations within the African-American community. The collection contains financial documents, correspondence, invoices, advertisements, minutes of meetings, printed materials, certificates, speech transcripts, membership applications, insurance policies, and examination reports.

Biographical Note

After visiting Dallas at the age of 17, Mrs. E. B. Crawford convinced her husband, Mr. E. J. Crawford, to leave Memphis, Tennessee and move there to start an undertaking business once he finished embalming school.¹ When they arrived in Dallas is unclear, though they established the Crawford Undertaking Company in 1909.² Mr. Crawford was involved in the civic life of Dallas, most notably for having founded and served as the first president of the Dallas Negro Chamber of Commerce in 1927, and for having been instrumental to the building of Good Street Baptist Church.³ After his passing on October 26, 1933, Mrs. Crawford became the sole owner and operator of the Crawford Undertaking Company, serving until 1946, when she stepped down and allowed for Mr. A. A. Braswell to take over.⁴ Mrs. Crawford also founded

the E. J. Crawford Burial Association, serving as the organization's president from its formation in 1945 until it became dormant in 1948.⁵

Mr. A. A. Braswell previously lived in Knoxville, Tennessee before moving to Dallas, although little is known besides his attendance at Knoxville College and his membership in Phi Beta Sigma fraternity there that dates from 1936.⁶ He was heavily involved in the civic life of Dallas, serving as the mayor of Negro Dallas in 1937, as the Chairman of Negro Day at the Texas State Fair after the passing of Mr. E. E. Ward, as the Executive Assistant to the Secretary in the Dallas Progressive Voters League in 1948, as a trustee and member of St. John Baptist Church, in the National Citizen's Committee for Re-electing Truman in 1948, as a member of the Board of Directors of the National Funeral Directors and Morticians Association, as President of the Independent Funeral Directors Association of Texas, and as President and Board Member of the Dallas Negro Chamber of Commerce.⁷ Mr. Braswell was also instrumental to the development of several businesses and organizations in Dallas, including First Grande Life Insurance Company, Sun Mutual Burial Association, Liberty National Bank, the Knights of Pythias Lodge No. 326, and the Knights of Pythias Federal Credit Union.

Mr. Braswell, along with Mr. R. A. Hester, was one of the organizers behind First Grande Life Insurance Company. Mr. Braswell initially served as Vice President, but was also the president at one point during the organization's history.⁸ The company was chartered in 1952, and was described as the "third old line legal reserve company" owned by African-Americans in Texas.⁹ It operated out of the Crawford building until it was sold to the American Woodmen's Life Insurance Company sometime between 1971 and 1972.¹⁰

Mr. Braswell was also President of the Sun Mutual Burial Association, which he organized in 1939.¹¹ The association operated out of the Crawford building, and Mrs. Crawford served as Chairman on the Board of Directors for the association.¹² Crawford Undertaking Company handled funeral services for members of this burial association.¹³

Beginning in 1964, Mr. Braswell served as Director and Chairman of the Executive Committee at Liberty National Bank, which described itself as one of the first interracial banks in the United States.¹⁴ The bank would later be known as Main Street National Bank.¹⁵

Mr. Braswell was also involved in the Knights of Pythias fraternal organization, serving as the Secretary Treasurer of the Endowment Fund and as Grand Keeper of Records and Seals for the Grand Lodge, Jurisdiction of Texas.¹⁶ He served as Chancellor

Commander of Lodge No. 326, which was chartered in 1961.¹⁷ Mr. Braswell worked with Mr. Hester to form the Knights of Pythias Federal Credit Union in 1970, serving as the organization's president and seeing over \$800,000 in assets for the financial institution as of mid-1975.¹⁸

Scope and Contents Note

The A. A. Braswell Collection contains the personal papers of both A. A. Braswell and Ella B. Crawford, along with the records of the E. J. Crawford Burial Association, First Grande Life Insurance Company, Sun Mutual Burial Association, Crawford Undertaking Company, Knights of Pythias Lodge No. 326, and the Knights of Pythias Federal Credit Union. The types of materials found within the collection include financial documents (such as reports, statements, and audits), correspondence, bills, invoices, and receipts, advertisements, minutes of meetings, printed materials (such as programs, pamphlets, and booklets), certificates (such as membership, stock, and death), speech transcripts, membership applications, insurance policies, and examination reports.

There are nine series in the collection: Ella B. Crawford/E. J. Crawford, A. A. Braswell, Crawford Undertaking Company, Knights of Pythias, Dallas, Manuscript Books, Cassette Tapes, and Visual Materials.

The first series, Ella B. Crawford/E. J. Crawford (1917-1953, Undated), is divided into two sub-series: The first sub-series, Ella B. Crawford Papers (1917-1953, Undated), contains the personal papers of Mrs. Crawford. These include bills and receipts, correspondence,

warranty deeds, bills of sale, tax information and financial documents, property abstracts, and estate papers. These are papers of Mrs. Crawford found within the collection that did not relate to Crawford Undertaking Company or the E. J. Crawford Burial Association. The second sub-series, E. J. Crawford Burial Association Records (1945-1952, Undated), includes correspondence, advertisements, examination reports, membership applications, and financial reports. These are records kept by the E. J. Crawford Burial Association.

The second series, A. A. Braswell (1936-1985, Undated), is divided into three sub-series: The first sub-series, A. A. Braswell Papers (1936-1985, Undated), contains the personal papers of Mr. Braswell. This includes bills and receipts, a large amount of correspondence, property documents, warranty deeds, releases of judgment lien, contracts of sale, policies, news releases, speech transcripts, notes, programs, minutes of meetings, and other materials that all pertain to Mr. Braswell's engagements outside of the businesses he operated. The second sub-series, First Grande Life Insurance Company Records (1952-1975, Undated), contains bills and receipts, bonds, financial statements and reports, minutes of meetings, correspondence, applications, blank letterheads, loans, notes, life insurance policies, advertisements, and stock certificates. These are records kept by First Grande Life Insurance Company, which was run by Mr. Braswell. The third sub-series, Sun Mutual Burial Association (1939-1952, Undated), contains certificates, correspondence, advertisements, financial information, examination reports, minutes of meetings, and membership applications. These are records kept by Sun Mutual Burial Association, which was run by Mr. Braswell.

The third series, Crawford Undertaking (1902-1984, Undated), is divided into three sub-series: The first subseries, Burial Files (1902-1982, Undated, Bulk 1940s), contains death certificates, funeral service pamphlets, obituaries, correspondence, notes, invoices, insurance policies, and life insurance policy notary forms. These files were maintained for people whose funeral service was held through Crawford Undertaking Company. The second sub-series, Business Records (1934-1983, Undated, Bulk 1930s-1940s), contains invoices, advertisements, correspondence, receipts, sales contracts, account statements, and business cards. These are records that were kept for the companies that Crawford Undertaking Company did business with. The third sub-series, Crawford Undertaking Company Records (1919-1984, Undated, Bulk 1940s), contains accounts, advertisements, news releases, audits, memorial booklets, pamphlets, correspondence, invoices, minutes from meetings, certificates, blank letterheads, death certificates, legal documents, memorial announcements, and monthly financial reports. These are the internal

records of the Crawford Undertaking Company.

The fourth series, Knights of Pythias (1940-1985, Undated), is divided into three sub-series: The first sub-series, Knights of Pythias Lodge No. 326 Records (1940-1985, Undated), contains advertisements, invoices, financial statements, correspondence, the organization's charter, minutes from meetings, audit reports, blank letterheads and forms, membership lists, membership applications, certificates, programs, pamphlets, monthly financial reports, and speech transcripts. These materials were generated by the Knights of Pythias Lodge No. 326 in Dallas. The second sub-series, Knights of Pythias Federal Credit Union (1963-1984, Undated, Bulk 1970s), includes account books, advertising, pamphlets, invoices, correspondence, certificates, speech transcripts, monthly financial reports, insurance policies, loans and notes, and annual statements. These materials were generated by the Knights of Pythias Federal Credit Union, a financial institution run by Mr. Braswell that was developed through the Knights of Pythias Lodge No. 326. The third sub-series, Receipt Books (1975-1979), contains receipt books generated by the Knights of Pythias Federal Credit Union, a financial institution run by Mr. Braswell that was developed through the Knights of Pythias Lodge No. 326.

The fifth series, Dallas (1916-1983, Undated), contains materials relevant to both the other series in the collection and the city of Dallas. This series includes title abstracts, advertisements, pamphlets, programs, correspondence, booklets, minutes of meetings, newspaper clippings, blank letterheads, speech transcripts, and printed materials. Some of the organizations and institutions represented are several local churches, the National Negro Business League, the Dallas Local Undertakers Association, local funeral homes, the Independent Funeral Directors Association of Dallas, Iota Phi Lambda, the Dallas Independent School District, and a general emphasis on minority businesses within the Dallas area. This series also contains tax information for Mr. E. J. Crawford, Mrs. Ella B. Crawford, Mr. A. A. Braswell, the Crawford Undertaking Company, and First Grande Life Insurance Company. These were kept in their original combined state and placed in this section due to the unclear nature of which person or organization was being represented on the forms.

The sixth series, Manuscript Books (1928-1971), contains manuscript books for Crawford Undertaking Company, consisting largely of financial records, such as disbursements, payrolls, daily records, business and income tax records, and income journals, along with two books containing death certificates.

The seventh series, Cassette Tapes (1972-1973, Undated), contains cassette tapes found in the collection. Three of the tapes were created by the Knights of Pythias Federal Credit Union, while the other four's origins are unclear.

The eighth series, Visual Materials (1945-1982, Bulk Undated), contains tintypes and photographs. These materials are listed at the item level in PastPerfect, and they are arranged into folders based on subject matter: 3 Tintypes from Griggs Bible, A. A. Braswell, Crawford Undertaking Company, Knights of Pythias, People, and Places.

The ninth series, Museum Objects (1946-1952, Undated), contains a checkbook for Mercantile National Bank, as well as several keys that were found within the collection.

This collection's materials expound on the nature of minority-owned businesses that operated in Dallas throughout the 20th century. This includes the Crawford Undertaking Company, the E. J. Crawford and Sun Mutual Burial Associations, the First Grande Life Insurance Company, and the Knights of Pythias Federal Credit Union. Minority fraternal organizations are represented through the Knights of Pythias. The collection offers additional insight into the role of black businessmen and businesswomen in the politics and general history of Dallas. Other areas of interest that are represented within include the undertaking, life insurance, burial association, banking, and federal credit union industries, as well as various minority organizations in Dallas.
